



# Concept note

It is very important that these hardships find you united in the need for a shared characterization of the current state and judicial role, and in the analysis of external influences in the – not always correct – choice of political and social models.*

**T**he colonization of territories ignited the first wave of globalization. Regular European transoceanic travel began in the 15th and 16th centuries for the first time systematically connecting lands and peoples that had been largely unconnected.<sup>1</sup> The European powers advanced on new lands, subdued them – militarily and politically but also culturally – and began a progressive, uninterrupted process of spoliation. Then, in the 19th and 20th centuries, colonization reached new heights with different characteristics and new protagonists, but with the constant objective of extracting wealth from lands and peoples. The nexus of colonial domination and extraction linked, in powerful and enduring ways, European powers to native lands in the Americas, Africa and Asia. The wounds of colonialism endure in many of the defining features of economy and society in the former colonialized lands.

The peoples subjected in the processes of colonial domination endured cultural, social, political and economic mutilations and mutations, mostly as a consequence of acts of violence, genocide, coercion, and demographic collapse.<sup>2</sup> Forced labor, slavery, territorial displacement, forced migrations, and the appropriation of natural resources were commonplace. The commodification of land and labor gave birth new forms of capitalism based on the violent extraction of profit from humankind and nature.

Colonization also meant the replacement of the original socio-cultural models by exogenous ones, which legitimized domination under various guises and created new axiological paradigms in accordance with their own needs. Supposed racial superiority codified in the violent pseudoscience of eugenics, vulgar ideas of the unilinear march of all humanity to “civilization,” and sometimes religion itself were some of the arguments used to consolidate the advance of colonial practices. Psycho-social violence and pseudo-scientific models of anthropological evolution ra-

cialized entire human populations as inferior and in need of paternalistic guidance.<sup>3</sup>

Native institutions were annihilated and along with them ancestral ways of thinking and knowing as well as the traditions that preserved a particular balance between human settlements and their natural surroundings. Psychological denigration and debasement of native mentalités became integral tools of domination.

The ideas of justice and the common good that existed in those territories prior to the conquest were suppressed and replaced by the “enlightened” ideas of the central powers. To this end, each and every one of the socialization channels was co-opted. Establishment culture and education disparaged pre-existing forms of thought and, under the guise of their barbarism, banished them from the new prevailing thought.

The decolonization processes that began with the independence movements of the 19th century and culminated with the last emancipatory events of the mid-20th century, did not lead to a reversal of domination. Although the format changed as the former colonies acquired new nominal statuses, in reality spoliation, political subjugation and cultural colonization are still very much alive today.

Neocolonialism, which is now twinned with neoliberalism, is thorough and implacable when it comes to consolidating results for global centrality. Today, formerly colonized peripheral countries have the international political status of free regions, but, in most cases, they are subjected to new economic and cultural paradigms of domination. The wealth of the colonizers is a necessary cause and consequence of the poverty of the colonized.

In the 21st century, the human face of neocolonialism are massive inequalities, ecological catastrophes, war and terror, and the mass catastrophic migrations from the formerly colonialized territories into the wealthier regions in Europe and North America. As an immigrant from the for-

mer colonies in the United Kingdom put it, “we are here, because you were there.”<sup>4</sup>

Justice and the common good were and are traversed by these processes of colonization, decolonization and neocolonialism. Viewing the institutions of Africa and America through that historical prism and understanding the current dynamics of domination and subjugation, allows us to shed some light on the contemporary tragedies of hunger, war, catastrophic migrations, displacement and marginalization referenced by Pope Francis in his famous encyclical *Laudato Si’*.

The Workshop will examine the neocolonial *problématique* from a Social Rights and Franciscan Doctrine. Our work shall focus on the neocolonial sequalae on current manifestations of injustice, global inequality, unchecked climate change, unsustainable development, and mass migrations. Above all we will highlight the role, of the institutions of society and the justice system in addressing and reversing said developments. The focus of this workshop be on the African and Pan-American contexts.

Cumbre sobre Colonialismo, Descolonialización y Neocolonialismo:  
Una perspectiva de justicia social y bien común

**L**a colonización de territorios encendió la primera ola de globalización. Los viajes transoceánicos regulares de las potencias europeas comenzaron en los siglos XV y XVI, conectando por primera vez de forma sistemática tierras y pueblos que habían estado en gran medida desconectados.<sup>1</sup> Los poderes europeos avanzaron sobre tierras y pueblos en las Américas, África y Asia, sometiéndolos - militar y políticamente, pero también culturalmente, iniciando así un proceso progresivo e ininterrumpido de explotación. Luego, en los siglos XIX y XX, la colonización alcanzó nuevas cotas con características diferentes y nuevos protagonistas, pero con el objetivo constante de extraer riqueza de las tierras y los pueblos conquistados. El nexo de dominación y extracción colonial vinculó, de forma poderosa y duradera, a las potencias europeas con las tierras nativas de América, África y Asia. Las heridas del colonialismo perduran hoy en muchos de los rasgos definitorios de la economía y la sociedad de las antiguas tierras colonizadas.

Los pueblos sometidos en los procesos de dominación colonial sufrieron mutilaciones y mutaciones culturales, sociales, políticas y económicas, en su mayoría como consecuencia de actos de violencia, genocidio, coacción y colapso demográfico.<sup>2</sup> El trabajo forzado, la esclavitud, los desplazamientos territoriales, las migraciones forzadas y la apropiación de los recursos naturales fueron moneda corriente. La mercantilización de la tierra y el trabajo dio origen a nuevas formas de capitalismo basadas en la extracción violenta de bienes comunes de la humanidad y la naturaleza.

La colonización significó también la sustitución de modelos socioculturales originales por otros exógenos, que legitimaron la dominación bajo diversos ropajes y crearon nuevos paradigmas axiológicos de acuerdo con sus propias necesidades. La supuesta superioridad racial codificada en

la violenta pseudociencia de la eugenésica, las ideas vulgares de la marcha unilineal de toda la humanidad hacia la "civilización" y, a veces, la propia religión fueron algunos de los argumentos utilizados para consolidar el avance de las prácticas coloniales. La violencia psicosocial y los modelos pseudocientíficos de evolución antropológica racializaban a poblaciones humanas enteras como inferiores y necesitadas de orientación paternalista.<sup>3</sup>

Las instituciones nativas fueron en muchos casos aniquiladas y con ellas las formas ancestrales de pensar y conocer, así como las tradiciones que preservaban un equilibrio particular entre los asentamientos humanos y su entorno natural. La denigración psicológica y el envilecimiento de las mentalidades nativas se convirtieron en herramientas integrales de dominación.

Las ideas de justicia y bien común que existían en esos territorios antes de la conquista fueron suprimidas y sustituidas por las ideas "ilustradas" de las potencias dominantes. Para ello se cooptaron todos y cada uno de los canales de socialización. La cultura y la educación del establishment menospreciaron las formas de pensamiento y sabiduría preexistentes y, amparándose en su barbarie, las desterraron del nuevo pensamiento imperante.

Los procesos de descolonización que comenzaron con los movimientos independentistas del siglo XIX y culminaron con los últimos acontecimientos emancipadores de mediados del siglo XX, no condujeron a una inversión de la dominación. Aunque el formato cambió a medida que las antiguas colonias adquirían nuevos estatus nominales, en realidad el expolio, la subyugación política y la colonización cultural siguen, vía otros caminos, muy vivos hoy en día.

El neocolonialismo, hoy hermanado con el neoliberalismo, es minucioso e implacable a la hora de consolidar los resultados de la centralidad mundial. Hoy, los países periféricos antiguamente colonizados tienen el estatuto político

internacional de regiones libres, pero, en la mayoría de los casos, están sometidos a nuevos paradigmas económicos y culturales de dominación. La riqueza de los colonizadores es causa y consecuencia necesaria de la pobreza de los colonizados.

En el siglo XXI, el rostro humano del neocolonialismo es la desigualdad creciente y obscura, la catástrofe ecológica, el terror de la guerra, y las migraciones masivas desde los territorios antiguamente colonizados hacia las regiones más ricas de Europa y Norteamérica. Como dijo un inmigrante de las antiguas colonias del Reino Unido, “estamos aquí porque ustedes estaban allí”.<sup>4</sup>

La justicia y el bien común fueron y son atravesados por esos procesos de colonización, descolonización y neocolonialismo. Viendo las instituciones de África y América a través de ese prisma histórico y comprendiendo las dinámicas actuales de dominación y subyugación, nos permite arrojar

alguna luz sobre las tragedias contemporáneas del hambre, la guerra, las migraciones catastróficas, el desplazamiento y la marginación a las que hace referencia el Papa Francisco en su encíclica *Laudato Si'*.

El Taller examinará la problemática neocolonial desde los Derechos Sociales y la Doctrina Franciscana. Nuestro trabajo se centrará en las secuelas neocoloniales en las manifestaciones actuales de injusticia, desigualdad global, cambio climático incontrolado, desarrollo insostenible y migraciones masivas. Sobre todo, destacaremos el papel de las instituciones de la sociedad y del sistema judicial a la hora de abordar y revertir dichos desarrollos. Este taller se centrará en los contextos africano y panamericano.


